### 3. Approval of the Minutes – 22<sup>nd</sup> September 2021

# 5. AOC Updated Code of Good Governance

- Identify and agree what further actions needed to be taken

## **RESOLVED**:

Governors reviewed the self-assessment document and suggested some further amendments. The Committee also agreed that College management was requested to provide additional information and evidence on compliance with the code where appropriate.

- Submit updated document for review at the June Committee meeting

### 6. Student Governor Election Process

Members considered the proposal to appoint Student Governors via a selection and interview process as not many students were putting themselves forward for election under the current arrangements. It was felt that this may encourage better attendance and engagement from student members at meetings.
